### What is FINS?

Families In Need of Services (FINS) is a legal proceeding including both formal and informal processes.

**INFORMAL FINS** is a voluntary pre-court intervention for a family that has a child for whom there is no pending investigation of abuse, neglect, or abandonment, or no court ordered supervision by the Department of Children and Family Services or the Office of Juvenile Justice. A child or family may be referred to the Informal FINS process of the Orleans Parish Juvenile Court for one or more of the following:

#### GROUNDS

- Child is truant (absence or tardy), or has willfully and repeatedly violated lawful school rules
- Child is ungovernable
- Child is a runaway
- Child has repeatedly possessed or consumed intoxicating beverages, or misrepresented age, or repeatedly loitered in area of liquor store
- Child has committed an offense applicable only to children (i.e., curfew, use of tobacco, tattoo, local ordinances, etc.)
- Child under 10 years of age has committed any act which if committed by an adult would be a crime under any federal, state, or local law (e.g., child under 10 commits burglary, murder, etc., child is guilty of a status offense rather than delinquent act)
- Caretaker has caused, encouraged, or contributed to the child's behaviors, or to the commission of delinquent acts
- After notice, a caretaker has willfully failed to attend a meeting with the child's teacher, school principal, or other appropriate school employee
- Child has been found incompetent to proceed
  with a delinquency matter
- Child is found to have engaged in cyberbullying

# Why choose FINS?

Families experience problems from time to time!

- ► FINS staff is knowledgeable and caring.
- FINS staff work to help evaluate your family's risks and needs, including identifying and coordinating services.
- FINS help children and families develop personalized plans to resolve an immediate crisis or on going problems.
- FINS can assist with scheduling convenient appointment times with providers.
- FINS will help you communicate with providers to assure you are receiving appropriate services.
- FINS has created partnerships with many agencies that will work with you in your home, school and community.

## **HOW DOES FINS WORK?**

The FINS process begins with a referral based on a violation of one or more of the ten (10) FINS grounds. The most common referrals are submitted by law enforcement, school officials, and parents.

## WHAT TO EXPECT?

### Our FINS case managers will work to connect you and your family with interventions designed to:

- Develop and set goals
- Identify and coordinate resources and services
- Provide individual and family counseling
- Offer mentoring and guidance
- Identify educational resources and support
- Develop and improve parenting and life skills
- Identify other appropriate and available resources

Every attempt is made to resolve the identified problems so that court intervention does not become necessary.
