- YOU MUST HAVE THE CONSENT OF BOTH PARENTS, IF BOTH ARE LISTED ON THE BIRTH CERTIFICATE
- \$165.00 FILING FEE OR AN IN FORMA PAUPERIS APPLICATION FILLED OUT AND NOTARIZED
